**POSITION OVERVIEW**: The law clerk will work closely with the Judge on all aspects of the docket and will be assigned responsibility for daily monitoring, research, and writing immediately upon entering on duty. The duty station for this position is Gulfport, Mississippi.

- 1. Legal research and writing; drafting orders and opinions for judicial review; providing information, guidance and advice to judges on legal issues relating to each case; and making recommendations to judges on individual cases.
- 2. Communicating with other courts, state and federal agencies, counsel, litigants and court staff regarding court rules and procedural issues, calendaring, and other litigation matters.

**EDUCATIONAL REQUIREMENTS AND EXPERIENCE**: Must be a graduate from an accredited law school. Bar membership, post-J.D. experience and/or extensive legal research and writing experience are desired.
