The United States District Court and Bankruptcy Court – Southern District Of Mississippi, are seeking proposals to provide support and maintenance services for the audio-visual and conferencing systems installed in twelve (12) courtrooms, three (3) conference rooms, and two (2) training rooms at the Thad Cochran Federal Courthouse in Jackson, MS.
