To Prospective Bidders:

The United States District Court and Bankruptcy Court for the Southern District Of Mississippi are seeking proposals to provide support and maintenance services for the audio-visual and conferencing systems installed in twelve (12) courtrooms, two (2) conference rooms, and two (2) training rooms at the Thad Cochran Federal Courthouse in Jackson, MS. These systems were initially installed in 2010 under the general construction contract held by the General Services Administration and most have received video enhancement upgrades. A contract for one year of maintenance is typically solicited each year. Interested vendors should reference the supporting Statement of Work. The Statement of Work will assist vendors in preparing to bid on the contract.

This is a request for Open Market Pricing. A firm-fixed price award will be made based on a lowest priced, technically acceptable offer. Coverage will commence on September 27, 2024. and terminate, unless renewed, one year later. Bids will be due before close of business on September 25, 2024.

Note: Interested vendors should note that the court cannot pay for a full year of maintenance up front. Following procurement regulations for maintenance contracts, the court will pay the winning bidder fifteen percent (15%) as an upfront payment, the remaining balance will have to be billed for payments to be made quarterly in arrears.
