Johnson), 5D (Magistrate Judge F. Keith Ball), 6D (Magistrate Judge LaKeysha Greer Isaac) in the Thad Cochran U. S. Courthouse located at 501 East Court Street in Jackson, Mississippi. Bidders are also encouraged to inspect the premises, systems and equipment currently in place in order to gain a full understanding of the needs, details, complexities, and potential difficulties associated with the project.

This is a request for Open Market Pricing. A firm-fixed price award will be made based on a lowest priced, technically acceptable offer. The work will be performed at the Thad Cochran Federal Courthouse located at the following address:

It is the intention of the court to make an award prior to September 30, 2023. Considering the limited time left in the fiscal year, the court strongly urges vendors to use care and diligence in preparing bids, as a Best and Final Offer (BAFO) round may potentially not be offered.

If you decide to submit a proposal, you will need to develop and provide both a technical proposal and a price proposal with respect to the "Primary" aspect of the project and each "Optional Additive." Your technical proposal shall consist of any submittals required to be provided at the time proposals are due. Your price proposal shall consist of the prices you are offering for each individual item of equipment, labor, any applicable travel costs, **and any other items you deem necessary to complete the project**. Subject to the availability of court funds, award of this RFQ will be made to the company whose technically acceptable proposal offers the lowest and best price to the court.

The electronic submission of your offer will be acceptable, provided an original is electronically signed by an individual authorized to do so. Your proposal must be submitted no later than **close of business August 31, 2023.** Proposals received after this date and time will not be considered.

At the time of acceptance of a bid by the court, the awardee will be required to execute a formal bid form and contract which meets the requirements of the Procurement Management Branch of the Administrative Office of United States Courts.
