Ex parte : Specific events and documents can be restricted to courts users and attorneys for the filing party. When placed on an event, NEFs are restricted to courts users and attorneys for the filing party, who also have access to any associated documents. When placed on a document, NEFs are sent to court users, all case attorneys of record, and attorneys with logins who list the case in their profile. However, only court users and attorneys for the filing party can access the specific document.
